# Items Typically Hauled Away as Junk

## Due to Condition, Safety, or Lack of Resale Value

This guide outlines items that are typically not suitable for resale or reuse due to condition, safety concerns, regulatory restrictions, or lack of market demand. It is intended to help quickly identify what requires Junk Removal Services for proper disposal or removal rather than evaluation or resale.

### Hazardous, Chemical & Regulated Materials

- **Paints, Solvents & Cleaning Chemicals:** Old paint, partially used chemicals, household cleaners requiring disposal
  - **Automotive Fluids & Oils:** Motor oil, antifreeze, gasoline, vehicle fluids
  - **Leaking Batteries & Corrosive Materials:** Damaged batteries, acid-containing items, corrosive materials
  - **Aerosol Cans & Pesticides:** Pressurized cans, insecticides, chemical sprays
  - **Expired or Regulated Chemicals:** Restricted substances, outdated chemical products

### Expired & Unsafe Food & Perishables

- **Expired or Opened Food Products:** Open packages, expired pantry items
  - **Perishable Foods:** Meat, dairy, produce, refrigerated goods
  - **Improperly Stored Food Items:** Heat-exposed or contaminated food
  - **Damaged Packaging:** Broken seals, leaking containers
  - **Rusted or Dented Cans:** Compromised canned goods

### Used Personal & Sanitary Items

- **Used Linens:** Worn sheets, towels, stained fabrics
  - **Used Comforters and Quilts:** Bedding with wear, odor, or staining
  - **Opened Toiletries & Cosmetics:** Used personal care products
  - **Medical Aids & Equipment:** Braces, walkers, personal-use devices
  - **Personal Hygiene Products:** Disposable or used hygiene items
  - **Used Undergarments:** Previously worn intimate clothing

## Clothing, Textiles & Fabric Waste

- **Torn or Stained Clothing:** Damaged garments, visibly worn clothing
  - **Moldy or Mildewed Fabrics:** Moisture-damaged textiles, odor-affected items
  - **Wet or Improperly Stored Clothing:** Storage-damaged clothing
  - **Unmatched or Worn Footwear:** Single shoes, heavily worn footwear
  - **Heavily Worn Textiles:** Used bedding, degraded fabric items
  - **Used Mattresses & Box Springs:** Restricted resale items, sanitation-regulated bedding

## Paper, Books & Media Waste

- **Moldy or Water-Damaged Paper:** Damaged books, compromised documents
  - **Outdated Manuals & Directories:** Low-relevance printed materials
  - **Damaged Media:** Broken CDs, DVDs, tapes
  - **Incomplete Books:** Missing pages, unusable books
  - **Bulk Paper Waste:** Low-value printed material

## Furniture with No Market Value

- **Low-Quality Furniture:** Particleboard, flat-pack furniture
  - **Damaged Furniture:** Broken frames, unstable pieces (excluding repairable MCM)
  - **Odor-Affected Upholstery:** Smoke, pet, or mold-contaminated furniture
  - **Large Bulky Pieces:** Sectionals, sofa beds, wall units in poor condition

## Construction & Renovation Debris

- **Broken Glass & Tile:** Shattered or unusable materials
  - **Used Carpet, Padding & Insulation:** Worn or contaminated materials
  - **Rotted Wood & Drywall:** Damaged building materials
  - **Concrete & Rubble:** Heavy debris and construction waste
  - **Windows:** Broken or outdated window units

## Broken, Damaged & Unsalvageable Household Items

- **Non-Working Electronics:** Broken or obsolete devices (excluding vintage/antique)
  - **Damaged Household Items:** Incomplete or broken items
  - **Warped Plastic Containers:** Deformed storage containers
  - **Expired Safety Equipment:** Old detectors, extinguishers
  - **General Household & Yard Waste:** Non-usable everyday items
  - **Rusted Metal Items:** Grills, patio furniture, appliances
